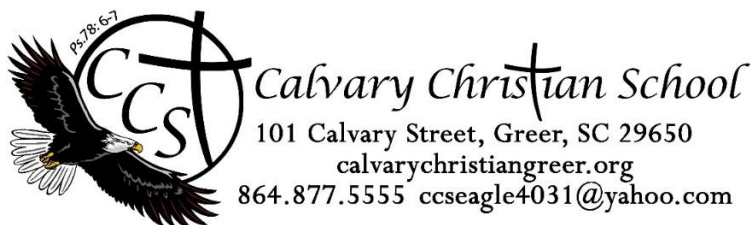
Step 4: Pay Final Fees

We desire, however, to stand firm on the Word of God and remain separate from the world while at the same time reaching out to the lost.

- We expect our students to be above reproach with regard to decency, honesty, integrity, and morality.
- Parents and siblings of our students are considered part of the "CCS family" and are expected to respect the church/school testimony by dressing in modest apparel while on campus or attending school functions. This includes field trips and sports events.
- We believe that a loving Christian environment includes rules and discipline for misconduct. It is our responsibility as role models to help guide each child to a closer walk with the Lord.
- The King James Version of the Bible is the only version that is allowed for teaching and memorization at CCS.
- Although we allow people of different denominations, we expect each student to comply cheerfully with the stand of the school. We will not permit any display of disagreement with the school's rules, standards, or beliefs.

Referral Incentive

Both the new parents and the referring parents must be current on their tuition payments in order for the referring parents to receive the tuition credit. 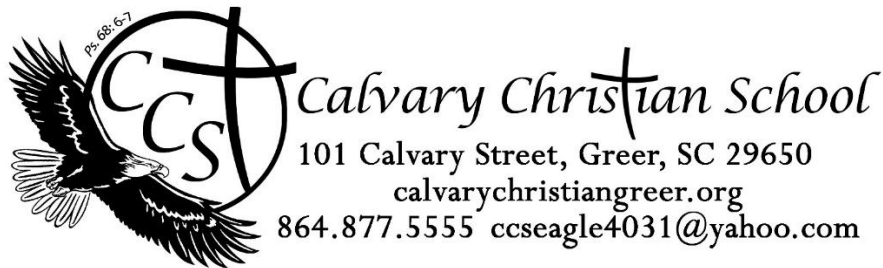

ESTF Funds Allocation Form

The Education Scholarship Trust Fund (ESTF), a program administered by the South Carolina Department of Education, allows qualifying South Carolina families to apply for a \$7,500 scholarship per student, per academic year. This program is designed to allow qualifying families to determine the best education customized for their child(ren). They have contracted with FACTS Management to process applications and determine eligibility, as well as Class Wallet to manage the distribution of the funds. Parents will use their Digital Class Wallet account to pay for approved expenses.

Calvary Christian School is an approved provider within the ESTF Program. Using their Digital Class Wallet account, parents will be able to make tuition and fees payments to CCS and make purchases from any other approved providers.

For those receiving the scholarship, a copy of your SC ESTF award letter (email) and this signed agreement must be submitted to the CCS office. Your invoices will then be customized with the details Class Wallet needs to approve payment to CCS for tuition and fees. You will submit the invoices to Class Wallet for approval; once the payment is received, it will be applied to your school account.
